# PROCEDURE OF TUITION FEE REDUCTION AT FACULTY OF MEDICINE OF VILNIUS UNIVERSITY

Pursuant to the Policy of Payment, Refund and Recovery of Tuition Fees of Vilnius University (hereinafter referred to as the University) approved by the Vilnius University Senate (hereinafter referred to as the Senate) by its decision No. S-2017-6-2 of 23 May 2017 (*recast decision No. S-2018-5-5 of 22 May 2018 of the Vilnius University Senate*), whose paragraph 37 of Chapter 4 provides for additional conditions for the reduction of tuition fees<sup>1</sup> to be approved by the councils of academic divisions, the following conditions of paragraph 37 have been approved by the Council of the Faculty of Medicine:

*37.1. Has expired as of 01/09/2018* 

### The repeal of the paragraph:

By the decision of the Council of the Faculty of Medicine No. (1.1.) 150000-TP-7-4 of 31/08/2018 pursuant to paragraph 1 of the decision of the Senate No. S-2018-5-5 of 22/05/2018.

37.2. By the decision of the dean of the Faculty of Medicine, to a student (or a resident) who is actively involved in the research activity of the University:

37.2.1. publications in Clarrivate Analytics Web of Science (ISI), when a student is 1-3 co-author – 90 percent;

- 37.2.2. in Lithuanian and foreign scientific journals indexed in *Medline, Index Copernicus*, *Current Contents*, *EBSCO* data bases, when a student is 1-3 co-author 50 percent.
- 37.2.3. winners or runners-up of Lithuanian scientific competitions from 30 to 90 percent.
- 37.2.4. winners or runners-up of world or European scientific competitions, co-authors of inventions patented in European Patent Office (EPO), United States Patent and Trademark Office (UPSTO) or Japan Patent Office (JPO) 100 percent.
- 37.3. By the decision of the dean of the Faculty of Medicine, to a student (or a resident) who has actively participated in the cultural activity of the University for at least two years as a member of one of the University's art clubs and has received a diploma, become a winner or a runner-up in international and national music, theatre, choir, folklore competitions or festivals as a representative of the University from 30 to 50 percent.
- 37.4. By the decision of the dean of the Faculty of Medicine, to a student (or a resident) who has been actively engaged in sports as a representative of the University:
- 37.4.1. who has been studying for more than 1 year from 30 to 50 percent;
- 37.4.2. who has become a winner or runner-up of Lithuanian championships, a winner or runner-up of SELL (student games of the Baltic states), a champion of Lithuanian students, who is a member of Lithuanian adult and youth teams, or a member of University teams from 30 to 90 percent;
- 37.4.3. who is a member or a candidate of the Olympic teams, who has become a world adult or youth champion or runner-up in his/her sports, a champion or runner-up of Europe, a winner or runner-up of world student championships -100 percent.

## The repeal of the paragraph:

37.6. By the decision of the dean of the Faculty of Medicine, to a staff member of the University who has worked in the University at least part-time for 10 months without interruption, for a period of one academic year – up to 70 percent depending on whether the studies chosen at the Faculty of Medicine will contribute to staff member's performance at work and facilitate his/her career at the University that is mutually beneficial or otherwise contribute both to the division of the University where the staff member is employed and the University.

- 37.7. By the decision of the dean of the Faculty of Medicine, to students orphans who have lost one or both parents and who have presented the documents certifying the fact of his/her father's or mother's death or a copy of the death certificate -50 percent.
- 38. Provided that a student has benefited from the Procedure of Students' Incentives of the Faculty of Medicine of Vilnius University and has received an incentive scholarship for certain activities, s/he shall not apply for the reduction of the tuition fee on the same grounds.
- 39. The tuition fee for a student is reduced for the current academic year.
